The meeting was called to order at 7:53pm. A quorum was present. President Sean Wilson chaired the meeting.

- 1. Sean moved to ratify the minutes of the September 27, 2017 meeting, David seconded. All in favor, the motion was approved.
- 2. David provided an upgrade report of normal activity.
- 3. Ramon provided a permitting report of normal activity.
- 4. Chris absent; no officials report. No issues emerging per remaining BOD on call.
- 5. Armin treasurer's report 2016 tax return filed. Armin has identified that there is evidence of less-than-complete payments from certain race directors. Plan: ID races most likely unpaid, refer to Ramon for review. Plan: chase unpaid race fees.

- 13. Discussion: Marilyn Allen request for funds to accommodate prospective track officials interning Saturday / Sunday at Masters Track Worlds. Generally favored. TBD in BaseCamp.

- 14. Discussion: Ramon proposes 50% reimbursement of Masters Track States and Frasier Park TT officials' mileage fee. TBD in BaseCamp.
- 15. Discussion Women's Western Collegiate Cycling Conference holding camp request for \$1,000 matching Title 9 attached. Sean proposed, Armin seconded, a grant of \$1,000. All in favor, approved.
- 16. Nick McKenna junior grant: Armin moved, Ramon seconded a grant of \$250 on previous pended application made prior to suspension of grant program.

- 18. There being no further business, David moved, Ramon seconded all approved the meeting adjourned at 10:12 PM.
